Section 1 Introduction & Methodology

Background to Designated and Non-Designated Heritage Assets in England

In England there are approximately 400,000 listed buildings, scheduled monuments, registered parks and gardens, protected historic wrecks and registered battlefields, and UNESCO World Heritage Sites. The importance and protection by the British legal system is readily understood, having been in place as early as 1882, but with the process as we now know it originating by a provision in the Town and Country Planning Act 1947 as a way of identifying buildings which should be repaired or rebuilt, if damaged or destroyed, as prompted by the destruction resulting from German bombing during World War II. Such historic assets are defined within the National Planning Policy Framework (NPPF) as 'designated heritage assets' and a list of these are maintained by Historic England.

The NPPF also has a second type of defined heritage asset; 'non-designated heritage asset'. Non-designated heritage assets are those of local interest which have a degree of significance to their locality, but do not meet the national criteria to become a 'designated heritage asset'. The NPPF outlines the process which should be followed when determining applications which impact on any historic asset (designated or non-designated) and non-designated assets may be identified through a number of different routes including: local heritage lists, local and neighbourhood plans, conservation area appraisals and reviews, and decision making during the planning process, i.e. the fact that an asset is a 'non-designated heritage asset' is determined during the course of a planning application. This informal designation does create significant uncertainty for applicants as theoretically any application could trigger an asset being identified as a 'non-designated heritage asset', with the extra scrutiny that brings and the potential requirement for additional information being required and abortive work if revisions are required to the proposed scheme. The Historic Environment section of the Planning Policy Guidance identifies the need for "all non-designated heritage assets [to be] clearly identified as such", with the publication of a local heritage list being the optimum solution to this requirement.

Non-designated heritage assets are not afforded the same legal protection as designated assets and therefore a building being identified as a 'non-designated heritage asset' does not place the same onerous burden on a property owner as national listed does. It does mean that some additional scrutiny is applied when determining applications relation to the asset, which does ensure high quality design is encouraged to protect the setting and aesthetic quality of both the asset and its surroundings, something which can only be a good thing.

Non Designated Heritage Assets in the Parish of Ringwood

The parish of Ringwood falls within the areas of two separate local planning authorities and both have a different approach to Local Listing. Whilst the New Forest National Park Authority publish a Local List which currently comprises of assets identified as part of the Conservation Area Appraisals, New Forest District Council do not currently maintain a Local List.

The closest thing available for the area is the 'Hampshire Treasures' volume for the district which was instigated as a result of the two "Countryside in 1970" conferences called on the Duke of Edinburgh's initiative in November 1963 and 1965. Hampshire began a pilot survey of 'Treasures' in 1967-68 and

subsequently rolled out across the county to produce draft reports. The revision of these draft reports lead to the definitive lists of 'treasures' published by Hampshire County Council between 1979 and 1986. The list of treasures included buildings already included on the national list of heritage assets. The New Forest volume was published in 1981. Hampshire Treasures has not been updated since the publication of the original volumes. Out of the 91 built assets identified for the Ringwood parish, 44 were already nationally listed, 34 have since been nationally listed, and 2 demolished. Thus 87% of the Hampshire Treasures in Ringwood were either then, or have subsequently been, protected at a national level (or demolished), undermining the function of the list. Hampshire Treasures can therefore no longer be viewed as up to date when utilised as a Local List. Hampshire Treasures is no longer publicised by Hampshire County Council, having been removed from their website in 2017.

In October 2019 the government announced a now £1,500,000 local heritage campaign to develop and update local lists within a series of pilot areas across the country. The country of Hampshire was awarded a grant to support such projects within the country, although not all Local Planning Authorities within the country chose to participate. New Forest National Park Authority chose to participate, New Forest District Council did not.

As part of the pilot scheme, New Forest National Park Authority are running a project, launched in late 2021, to update and expand their existing local list through an invited submission process publicised on their website, with submissions currently being assessed before their inclusion is discussed at meetings of their planning committee. This exercise includes the parish of Ringwood.

The Ringwood Local List

As part of the work in assembling the Ringwood Neighbourhood Plan, the Design and Heritage Working Group were given a number of tasks to contribute to the compilation of the plan. One of these was producing a local list of non-designated heritage assets which would form part of the Neighbourhood Plan. The process of compiling this list began in Spring 2021.

Historic England have published an Advice Note: Local Heritage Listing: Identifying and Conserving Local Heritage (Historic England Advice Note 7 (2nd Edition)), and this sets out advice on how such lists are compiled, updated and provides criteria against which assets can be evaluated. The Neighbourhood Plan Design and Heritage Working Group has adopted a process for nominating assets based on the Advice Note. They have also collaborated with the New Forest National Park Authority conservation officers running their Local List project and have benefited from the expertise of the Building Design and Conservation Officers, and Heritage Project Co-Ordinator.

The Process

1 - Nomination

Members of the public have been invited to nominate candidates for inclusion on the Local List and the method for doing so has been through an online process based on the Historic England Advice Note. The online submission form is available through the Ringwood Neighbourhood Plan website and has been promoted on social media. In addition a sub-group of the the Ringwood Neighbourhood Plan Design and Heritage Working Group have been undertaking desktop and field research to identify potential candidates for inclusion through the use of cartographic sources and travelling the many roads and lanes of the parish in an attempt to ensure that all potential assets have been identified.

The potential assets for inclusion on the Ringwood Local List can be categorised as having come from the following sources:

Online submissions from public through Ringwood Neighbourhood Plan website

Online submissions from public through responses to social media posts

Direct correspondence from Ringwood Society committee/secretary

Direct correspondence from interested members of the public

Direct correspondence from interested property owners

Invitations from interested local organisations

Identification of Hampshire Treasures which have not subsequently been nationally listed

Identification of assets identified in Ringwood – A Conservation Area Appraisal – New Forest District Local Plan Supplementary Planning Guidance (2003)

Identification of assets through visual identification

2 - Preparation of Draft Local List

Once the nominations have been received, the Ringwood Neighbourhood Plan Design and Heritage Working Group will review the submissions, discount any nominations which are already nationally listed or are not suitable for inclusion on the Local List and assess them against the criteria set out in the Historic England Advice Note. These are:

<u>Age</u>

The age of an asset may be an important criterion, and the age range can be adjusted to take into account distinctive local characteristics or building traditions.

Rarity

Appropriate for all assets, as judged against local characteristics.

Architectural and Artistic Interest

The intrinsic design and aesthetic value of an asset relating to local and/or national styles, materials, construction and craft techniques, or any other distinctive characteristics.

Group Value

Groupings of assets with a clear visual design or historic relationship.

Archaeological Interest

The local heritage asset may provide evidence about past human activity in the locality, which may be in the form of buried remains, but may also be revealed in the structure of buildings or in a designed landscape, for instance. Heritage assets with archaeological interest are primary sources of evidence about the substance and evolution of places, and of the people and cultures that made them.

Historic Interest

A significant historical association of local or national note, including links to important local figures, may enhance the significance of a heritage asset. Blue Plaque and similar schemes may be relevant. Social and communal interest may be regarded as a sub-set of historic interest but has special value in local listing. As noted in the PPG: 'Heritage assets ... can also provide meaning for communities derived from their collective experience of a place and can symbolise wider values such as faith and cultural identity'. It therefore relates to places perceived as a source of local identity, distinctiveness, social interaction and coherence, contributing to the 'collective memory' of a place.

Landmark Status

An asset with strong communal or historical associations, or because it has especially striking aesthetic value, may be singled out as a landmark within the local scene.

In order to assess the nominated asset against the criteria, further desktop research will be undertaken to ascertain information not available as part of the submission or from a visual inspection. Information will be gleaned from several sources including:

Assets outside of the New Forest National Park

In communication with the Ringwood Neighbourhood Plan Steering Group, a list of assets which after being assessed, have a sufficient level of interest when scored against the criteria, is then produced and circulated to Ringwood Town Council for information.

The next step is "Notify Building Owners and Publication of Draft Local List", see below.

Assets and their assessment against the selection criteria are submitted to the New Forest National Park Authority either by email in bulk, or via their online nomination form, as appropriate, for assessment through their own process including notification and consultation. Refer to the New Forest National Park Authority for more details of their process of assessment and designation.

The next step is "Use the Adopted Local List", see below.

3 - Notify Building Owners and Publication of Draft Local List

Ringwood Town Council uses the draft list of assets to write to each address, outlining the Local List project and giving notice of the intention to include that asset on the list. The criteria for inclusion of each asset is included on the letter tailored to each asset. The letter invites a response including approval, objection and an opportunity for the recipient to provide further information to enrich the Local List, and directs responses to Ringwood Town Council for collation. A minimum of 28 days will be allowed for responses. Alternatively/additionally the draft Local List could be made available online through the Ringwood Neighbourhood Plan website for consultation by all interested parties.

4 - Receive Additional Information, Comments and Objections

Ringwood Town Council receives responses from recipients of notification letters and any online consultation process through the Ringwood Neighbourhood Plan website. It is not expected that the Local List would include assets against the wishes of the asset owner, other in exceptional circumstances e.g. an extremely important building in the core of the town centre.

Ringwood Town Council will then provide the consultation responses to the Ringwood Neighbourhood Plan Design and Heritage Working Group to enable additional information to be included in the Local List.

5 - Update the Draft Local List

Ringwood Neighbourhood Plan Design and Heritage Working Group to make necessary updates to individual entries accordingly. Photos of each individual asset will be obtained from public land, or with consent of the building owners and collated for inclusion with Local List proposed for adoption.

6 - Adopt the Local List

The proposed Local List will be included within the Ringwood Neighbourhood Plan for adoption and consulted on with the public at referendum. The Local List element will include the supporting assessment against the selection criteria set out in the Historic England Guidance Note, along with photographs wherever possible.

7 - Use the Adopted Local List

The adopted Local List will be used by Ringwood Town Council to inform their responses to planning applications and by the Local Planning Authorities (New Forest District Council and New Forest National Park Authority) in responding to pre-application enquiries and determining applications through the planning system.

8 - Maintain the Local List

A review will be undertaken of the Ringwood Local List after a period of 5 years, whether or not as part of the Neighbourhood Plan cycle. If outside of the Neighbourhood Plan cycle, Ringwood Town Council will convene a panel to undertake this review. The panel may include Town Councillors and members from other groups such as (though not specifically); the Neighbourhood Plan and the Ringwood Society.

Ringwood Town Council can at any time repeat the steps above to amend the list, adding, removing or updating entries, including on an ad hoc basis for individual assets.

Publication

The Ringwood Local List will be published and publicly available as part of the Ringwood Neighbourhood Plan.

In addition it is the ambition of the Ringwood Neighbourhood Plan Design and Heritage Working Group to produce an illustrated document presenting the Local List in a bespoke document, to record the non-designated heritage assets of the parish. This would take place once all likely candidates for nomination have been assessed. It is currently envisaged that a copy might be lodged in locations such as the following, for both public consultation/information and posterity:

Ringwood Town Council
New Forest District Council
New Forest National Park Authority
Ringwood Library
Ringwood Meeting House
Ringwood Society
Hampshire Record Office

This ambition would be reviewed at the relevant point for feasibility and against funding opportunities available at the time.

Section 2 Detailed Examples

2 Market Place (ex Ringwood Shopping Centre, Regal Cinema, Town Hall and Corn Exchange)

2 Market Place, Ringwood, Hampshire, BH24 1AQ

Former town hall and corn exchange subsequently converted to cinema (later rebuilt), since converted to commercial/retail uses. Now derelict.

Age – Y - Originally built in 1868, sold by the Morant family as part of the sale of the Ringwood Estate in 1916 at which point it was converted into a cinema; The Picture House. Became The Victoria cinema in 1931. Rebuilt in 1937 when the interior was gutted, the mansard roof and chimneys were removed, along with the original ground floor design, first floor window glazing and balcony ironwork including the Morant family crest. Having closed as a cinema in 1972, the building was reconstructed as a shopping centre, restaurant and squash club opening in 1977. The shopping centre and squash club closed in 1990 after which the building became a nightclub before closing and falling into disuse from 2002.

Rarity – Y - The building makes a formidable impact on the Market Place and is unusual for the town in both its scale and style. Fragments of the buildings time as a cinema remain in the shape of the stained glass metal framed windows at first floor level and the partial remains of a sweeping staircase to the east side of the front block (ex Town Hall). Bricked up remnants of one of the arched topped windows of the Corn Exchange remain in the southernmost bay of the west elevation.

Architectural and Artistic Interest – Y - The façade is built in a French classical style, which is very unusual for the town. The quality of the original building is apparent from the choice of Bath stone for the stonework.

Group Value – Y - The building, despite current dilapidation, makes and important contribution to the setting of the Market Place and perhaps can be considered the lynchpin around which the whole Market Place revolves, if nothing else it is dominated by it.

Archaeological Interest – N

Historic Interest – Y - Originally built at the expense of Mr John Morant, the Lord of the Manor of Ringwood. Originally designed by Thomas Henry Wyatt who would go on to be the President of the Royal Institute of British Architects between 1870 and 1873 and win the RIBA Royal Gold Medal in 1873. Originally built by built by Messrs Bull & Son of Southampton. 1937 reconstruction designed by prolific cinema architect; Ernest S Roberts. During the 1960s the building hosted gigs by Status Quo, Dave Dee Beaky Mick and Tich, The Troggs, Edison Lighthouse, Unit 4 + 2 and Amen Corner.

Community/Social Value – Y - The buildings many years as a cinema showing films, hosting concerts and as home to the Ringwood Musical Dramatic Society has earned the building a special place in the heart of the town, perhaps above any other single building within the town.

Landmark Status – Y - The sheer impact of the building on the Market Place demonstrates its ability to be considered a landmark, both in size, style and grandeur (of the original design, rather than the current state of repair).



Ringwood Sports Centre

Parsonage Barn Lane, Ringwood, Hampshire, BH24 1PX

Built around an existing sports hall, the building includes sports hall, squash courts, 25 metre swimming pool, learner pool, cafeteria and bar

Age – Y - Completed 1982 (Single storey extension to South - 1988)

Rarity – Y - As identified in recent press coverage (AJ 21/04/2021 and RIBAJ 19/08/2021), this is a typology which is becoming increasingly rare, along with being one of a decreasing number of works by Hampshire County Architects, several of which are now listed buildings (Portsmouth News 20/10/2017 and Southern Daily Echo 25/06/2018). The Twentieth Century Society are currently running a pilot campaign which has submitted ten leisure centres around the country for national listing by Historic England, Historic Environment Scotland and Cadw (Wales), as a demonstration of the importance of preservation of this building typology, building upon recent listings of Swindon's Oasis Leisure Centre and Bradford's Richard Dunn Sports Centre.

Architectural and Artistic Interest – Y- A strong example of 1980s Post-Modernist architecture with exposed structure and services created by RIBA Royal Gold Medal winning architects of Hampshire County Council Architects (Sir Colin Stansfield Smith, chief architect of Hampshire County Council at the time stated the 1991 award, whilst awarded personally due to the rules applicable at the time was, in his view, awarded to all staff in the department). The architectural interest of the building is confirmed by it's receipt of a Commendation at the 1983 BSCA and BSC Structural Steel Awards, and the buildings publication in The Architect's Journal – April 1 1981, The Architect's Journal – October 20 1982, Building Design – August 6 1983

Building with Steel – December 1983, Interior Design – April 1984, Hampshire Architecture by Terry Farrell, Edward Cullinan, et al – 1985, Schools of Thought – Hampshire Architecture 1974-1991 by Richard Weston – 1991, and The Buildings of England: Hampshire: South by Nikolaus Pevsner et al – 2018 Revised Edition.

Group Value – N

Archaeological Interest – N

Historic Interest – Y - Featured in the BBC Television series; The Brittas Empire (1991-1997), as Whitbury New Town Leisure Centre (exterior and some interiors). Designed by Hampshire County Council Architects, recipients of the 1991 RIBA Royal Gold Medal. The job architects were David White, Norman Roberts, Peter Galloway; and their assistants were Alec Upton, Peter Hayne, John Laye, Dennis Goodwin, Kevin Harnett. The engineers for the building were the world renowned firm of Anthony Hunt Associates.

Community/Social Value – N

Landmark Status – Y - As a public building, the building has strong communal associations with leisure and heath in the local community



Royal Mail Pillar Box at Meeting House Shopping Centre

Meeting House Lane, Ringwood, Hampshire, BH24 1EY

A Royal Mail cast iron pillar box

Age – Y - Type G pillar boxes were manufactured by the Carron company between 1974 and 1979.

Rarity – Y - Over time post boxes have had a tendency to be replaced and thus any box with an historic design is one of a diminishing pool. This design of pillar box was not popular with the public and production ceased after only 5 years to be replaced by a modern interpretation of the cylindrical pillar box. The Type G therefore remains a less common design and a rare site in general circulation having only been installed new for a short period of time, given the longevity of pillar box installations.

Architectural and Artistic Interest - Y - This cast iron pillar box design was designed to provide a modern evolution of the traditional round pillar boxes which preceded it. The rectangular shape allowed a new internal mechanism, which meant that the box could be emptied much faster. Two boxes could also be placed side-by-side to form a double aperture box.

Group Value – N

Archaeological Interest – N

Historic Interest – Y - The cipher itself and the design of it are both intrinsically linked with Queen Elizabeth II. The Type G pillar box was an evolution of the experimental Type F pillar box manufactured in steel in 1968 to designs by reputed industrial designer; David Mellor. The Carron Company, based in Falkirk, Stirlingshire was the largest iron works in Europe during the 1800s and had a long history stretching from its foundation in 1759 until going into receivership in 1982.

Community/Social Value – N

Landmark Status – Y - Royal Mail post boxes are a cherished feature of the British street furniture scene, and are acknowledged as such by a Joint Policy Statement co-signed by Royal Mail; the Department for Culture, Media and Sport; Historic England (and its sister organisations in Scotland, Northern Ireland and Wales); The Postal Museum; and the Letter Box Study Group. The JPS is founded on the principle that post boxes make a significant contribution to the character and appearance of the areas in which they are located. This policy follows the recommendation set out in Power of Place: The future of the historic environment (English Heritage 2000) that wherever possible historic buildings and structures should be retained by agreement with their owners rather than relying solely on statutory designation and this advice is endorsed in A Force for Our Future (DCMS 2001).

Criterion	Description
Age	An asset that displays national or local trends/practices/way of life that is representative of a historic period or changes over time. Broadly speaking the older the asset is, the rarer it is likely to be.
Rarity/Representativity	An asset that is characteristic of the New Forest. Or a rare survival of an asset type less commonly found in the New Forest e.g. encroachment cottage or a commemorative monument.
Architectural/Artistic Interest	The intrinsic design and aesthetic value of an asset relating to local and/or national styles, materials, construction and craft techniques, or any other distinctive characteristics. This could be an example of outstanding modern design.
Group value	
	Multiple assets meeting the criteria that are linked by design or historic association. Related or designed landscapes that directly contribute to the setting of other assets should also be included under these criteria e.g. boundary walls or railings, or groups of estate buildings, terraces of cottages etc.
Archaeological Interest	The potential for evidence of past human activity above or below ground or in the wider landscape to add archaeological knowledge e.g. barrows, WW2 military remains etc.
Historic Interest	The asset has links to nationally or locally notable people, events, economic trends, or social/cultural history e.g. architects such as Heywood Sumner, or Arthur Hugh Clough, munition works, or Jubilee/Millennial commemorations.
Landmark Status	
	An asset that is recognised as a landmark or a communal gathering point in the local area e.g. a village green, railway station, clock tower or memorial etc.
Community/Social Value	
	An asset that creates a sense of belonging and/or shared identity and is valued by its local community or other interested communities. This could be because of the history, the spiritual association or how it is/was used within the community e.g. village hall or meeting room.

In Historic England's view, any one of these characteristics could provide the basis for considering that an asset makes a positive contribution to the special interest of an area, provided that its historic form and values have not been seriously eroded by unsympathetic alterations.
